#### **Treasurer's Report**

The financials have been audited, and no issues were found. The report will be presented in May.

#### Casino Bank Balance = \$62,182

• Transactions include library books (\$1,463), art supplies (\$1,123), regulation materials (\$1,014) and field trip bussing (\$544). Another \$5,000 in Phys. Ed Equipment to be considered in the spring, as well as more library funds after the book fair and potential book drive campaign. It was noted that we are not part of the Indigo 'Adopt a School Program' and therefore, the council will not be proceeding with a book registry with Indigo. A list of desired books should be compiled, in conjunction with the librarian, and published to parents and the surrounding communities for donation from personal collections or purchase.

### Non-Casino Bank Balance = \$13,561

- \$1,348 was raised from the apple fundraiser, compared to \$870 last year.
- \$220 donation was received anonymously via Benevity.
- Healthy Hunger has raised \$575 to date.
