School Improvement Results Reporting | 2023-24

Each year, schools capture evidence of continuous improvement towards the goals set. In accordance with Alberta Education's Requirements for School Authority Planning and Results Reporting, schools then provide assurance to school communities by communicating student growth and achievement in an annual report that demonstrates improvement results and next steps. These results support continuous improvement of the quality and effectiveness of education programs provided to students while also improving student learning and achievement (Funding Manual for School Authorities 2024-25 School Year p. 196).

This report includes results relative to the goals and outcomes set in the 2023-24 School Development Plan and the school's Assurance Survey results.

Our School Focused on Improving

Our School Focused on:

- reading fluency
- mathematical procedural fluency
- develop and demonstrate empathy for themselves and those around them

We chose to focus on these areas as our student data as measured on report cards and on provincial assessments (LeNS, CC3 and Numeracy) indicated that gaps in these foundational skills were limiting students' ability to engage fulsomely in reading and math situations. We also noticed, based on the CBE Student Survey results as well as teacher perceptions, that students were reluctant and/or did not understand their role in social and learning scenarios.

What We Measured and Heard

We primarily used the LeNS, CC3 and Numeracy Provincial Screeners as well Report Card Stem Data as to measure growth in the areas of literacy and mathematics. We noted the following:

It is important to note, that Wildwood School increased in enrolment from 412 to 546 from September 30, 2023 to June 28, 2024. This had a significant impact on all data.

Our data demonstrates improvements in literacy and declines in math for our 'at risk students'.

Along with above data standardized assessments and achievement data, we noticed an improvement in our combined perception data (CBE Student Survey (Spring 2024), AEA Survey (Spring 2024) and OurSCHOOL (Fall 2023) related to Diversity and Inclusion.

The significant enrolment growth created an unanticipated and unprecedented circumstance for students to demonstrate empathy to themselves and others. Our students repeatedly demonstrated resilience, flexibility and understanding adjusting their daily routines, cultural norms, spaces (classrooms, hallways, outside spaces), instruction and overall school culture. Empathy, abounded.

Analysis and Interpretation

What We Noticed

LeNs and CC3 data indicate that there has been a significant decrease in the percentage of students in the at-risk category in literacy. Mathematics data from report Cards points to an improvement for our kat-risk students. However, the Numeracy Assessment points to an increase. This is contradictory.

Coupled with data from the CBE Student Survey and questions posed to student in class these data not only point to improvements in students' reading, but also to their ability to demonstrate empathy.

In addition to student data, our parents have reported high and very high levels of satisfaction. This is maintained from last year.

Celebrations

- Students' decoding skills have improved
- Students' numeracy skills have improved
- Students are consistently demonstrating empathy to themselves and others
- Our data indicates a significant increase in parental involvement

Areas for Growth

- Align mathematical instruction and routines into daily practice
- Onboarding data for new students
- Provide targeted intervention for LP1/2 students at all grade levels
- Connect conceptual understanding to procedural fluency in mathematics
- Diversify opportunities for parent involvement
